

## By purchasing a ticket, you agree to all Terms and conditions of entry to Animal Land

### Ticket conditions

- Farm Liability Waiver / Release
- General admission pre-purchased tickets are valid date of tour purchased.
- Single entry only
- Non-refundable
- Lost, stolen or destroyed tickets cannot be replaced.
- Animal Land reserves the right to request proof of age.
- Children 15 years and under must be supervised by an accompanying adult. An adult is deemed to be any person aged 16 years or older.

### Farm Liability Waiver Release

By Purchasing an admission ticket, I hereby acknowledge to Animal Land, (The PF Factor Pty Ltd & L & J Pincini), that:

1. I am actively aware of the risk(s) and danger(s) of participating in a class/activity on a farm and working around livestock, which includes horses, ponies, sheep, alpacas, goats, cows, chickens, ducks, dogs, and any other animal at Animal Land properties can result in Death and/or Injury
2. I assume all foregoing risk of using to Animal Land, (The PF Factor Pty Ltd & L & J Pincini) property, and accept personal responsibility for damages from my use, including, but not limited to injury, disability, or death.
3. I release, waive, and discharge Animal Land, (The PF Factor Pty Ltd & L & J Pincini), from any and all liability to me, my heirs, and next of kin for any and all claims, demands, losses, or damages, related to my use of Animal Land, (The PF Factor Pty Ltd & L & J Pincini), property.
4. I agree to accept full responsibility for any guest whom I bring to Animal Land, (The PF Factor Pty Ltd & L & J Pincini) property, and will defend and indemnify Animal Land, (The PF Factor Pty Ltd & L & J Pincini) against any claim brought by such person. I have read the above waiver and release, understand that I give up substantial rights by purchasing a ticket,
5. By Purchasing a ticket, I acknowledge that I am virtually signing this waiver voluntarily.

### Terms and conditions of entry

Animal Land set the terms and conditions of entry to Animal Land Farms managed under its administration.

A person must not, while in the Farm and managed land:

1. **Light or smoke cigarettes or e-cigarettes on any part of the premises. (including Car Parks)**
2. Without permission, take or bring animals into its property, with the exception of Assistance Dogs which are permitted to enter Animal Land.
3. Offer food to the animals. (unless provided by authorised farm staff)
4. Disobey or fail to comply with a notice, sign or direction erected by Management. All guests must abide with any other conditions displayed in Farm grounds or communicated by Farm staff
5. A guest is not permitted to bring into Animal Land any animal; ball; balloon; bicycle, scooter, skateboard, roller blades or similar apparatus; alcohol or illegal substance.
6. Without permission wade, swim or bathe in any lake, pond, stream or dam on its property.
7. Light a fire other than in a place provided for that purpose.
8. Mark, deface, write on, in any way damage any of the Board's property.
9. Without permission play, use or operate musical instruments, equipment and items (whistles and water pistols) that may interfere, disrupt or annoy animals or other person.
10. Without permission erect structure such as tents, beach umbrellas or similar structures within its property.
11. Without permission hawk, sell or offer for sale or hire any items or distribute handbills, pamphlets, notices or other advertising materials.
12. Without permission, a guest is not permitted to conduct any commercial activity in Animal Land grounds including the use of any media equipment.
13. Without permission deliver any public lecture or public speech of any kind.
14. Children under 15 years of age must be supervised by a person (16 years or older).
15. Children must be supervised by an accompanying adult at all times. It is an express condition of your entry and your participation in the activities conducted by Animal Land that you do hereby, for yourself, your heirs, executors, assigns and next-of-kin and each of them release, waive and discharge Animal Land its officers, directors, agents and employees of and from all liability, claims or demands for all injuries, losses, damages of any kind or nature to your person or property or to that of any minor under your supervision, while on the property of Animal Land.

Visitors who breach any terms and conditions of entry will be asked to cease these activities. Failure to comply will result in visitors being escorted from Animal Land and associated properties.

Farm Management and Farmers have the authority to close the Farm or any part thereof, including any animal exhibit or show, at any time they deem it necessary and will not be liable for any loss or expense occurred by a visitor as the result of such closure.
